OSHA Requirements for Participation

- You must be present, visible, and participating, focused on the class for a minimum of 10.0 hours, not including breaks or meals. The instructor is required to sign a sworn affidavit regarding your attendance, so attendance may be taken randomly during the course.
- No multi-tasking. No watching movies in the background. No handling emails or web surfing on a separate screen.
- Don't be in front of a window where we can only see your shadow.
- Dress as if you were attending the class in person.

Our OSHA 10-Hour General Industry course is a two-day, 10-hour LIVE video conferencing training program. Specifically geared toward, **the course provides "awareness level" training** and is intended to increase awareness of certain factors that contribute to safety risks and injuries among industry personnel. A focus on general industry safety and health hazards a worker may encounter on a worksite are also discussed, as is an emphasis on hazard identification, avoidance, control, and prevention. Additionally, the course provides information on employee rights, employer responsibilities, and how to file a complaint.

Registration for day one of this course automatically registers you for day two.

- Bloodborne Pathogens (1 hour)
- Ergonomics (1 hour) • Safety and Health Program (1 hour)
- Fall Protection (1 hour)
