In keeping with our goal of providing you with the tools and resources to assist you in creating a robust cyber security program for your municipality, we would like to share the following information with you from the MassCyberCenter

SAVE THE DATE: Cyber Incident Response Planning Workshop 2

The MassCyber Center is scheduling the second of two free workshops to develop your municipality's Cyber Incident Response Plan for municipalities within the following Homeland Security Regions for the following dates:

- Western Homeland Security Region, Wednesday, September 2, 10 a.m. to noon
- Southeast Region- Wednesday, September 9, 10 a.m. to noon
- Central Region- Wednesday, September 9, from 1 to 3 p.m.
- Metro Boston Region- Thursday, September 10, 10.a.m. to noon.
- Northeast Region- Monday, September 14, 10 a.m. to noon

Formal invitations and registration links will be coming soon.

Workshop 2 will pull together the final details of the cyber incident response planning process and provide an opportunity to test the plan. This will be a two-hour "virtual" workshop and MIIA members will be eligible for MIIA Rewards credits.

Background

These workshops are funded by the Commonwealth of Massachusetts via the MassCyberCenter at MassTech Collaborative. The program is presented by Linn Freedman, Partner and Chair of the Data Privacy+ Cybersecurity Team at Robinson +Cole. More information on the workshops can be found here

Workshop 1, held regionally in mid July, focused on introducing the need for cyber incident response plans, providing self-assessment and planning guidance, and giving municipalities the tools and resources they need to create a cyber incident response plan.

All municipal management, information security teams, and/or first responders are encouraged to participate in these workshops. **You may attend Workshop 2 even if you did not attend Workshop 1**.
